## The Information We Collect

1. **Personal Information:** Magnus Vision will collect personal information from you when you order or register on our site, as appropriate. This may include your first name, last name, email address, etc. For example, by completing a “contact us” form or leaving a comment, we could use that data to help you receive the information or services that you require, or to respond to your comment. Submitting this personal information is completely voluntary. This information will be retained by Magnus Vision.

2. **Non-Personally Identifiable Information:** Magnus Vision collects information about your activities when you visit magnusvision.com. This includes:

- Date, time, and duration of visits.
- The amount of data transmitted from Magnus Vision to you.
- Internet domain name.
- Information about the computer setup (e.g., browser type, operating system, screen resolution, and connection speed).
- Internet Protocol (IP) Address.
- The specific pages you access.
- Referring to a website.
- Third-party hosted content.

### Collecting the Information

1. You submit your personal data into the various forms on magnusvision.com.

2. Magnus Vision uses third-party providers of analytics, including Google Analytics, to analyze the data collected during visits and persistent metrics cookies to enhance the website, our services, and our advertising. The third-party providers of analytics do not receive personally identifiable information through these cookies and do not combine, match, or cross-reference Magnus Vision's information with any other information.

3. Magnus Vision uses web measurement and customization technologies (such as cookies) to improve the functionality of magnusvision.com. When you visit magnusvision.com, your internet browser may download and save a “cookie” (a small file) so we can recognize your computer and browser every time you use magnusvision.com. These cookies fall into two categories:

- **Single-session cookies:** Only operate while your web browser is active. When the browser is closed, the cookies are deleted.
- **Multi-session cookies:** Operate longer than a single session on a browser, allowing a website to recognize a computer or user (for a defined amount of time).

### Use of the Information

- **Cookie Information:** We use cookies to optimize the usability of our site and to enhance our advertising. For example, cookies aid site usability by storing your email address or login ID (but never your password). They will also be used to confirm when you have reached a certain page and will inform us on how you interact with our adverts. This helps us personalize the adverts that you see.

- **Site Activity Information:** We keep track of pages visited, length of visit, links clicked, forms submitted, and downloads.

- **Access Device and Browser Information:** When using a computer or mobile phone (or any other device) to access magnusvision.com, information may be collected from that device regarding browser type, location, IP address, and pages visited.

- **Links:** If you click on a third-party link, you are leaving magnusvision.com and are being transferred to an external site. These external sites have their own privacy policies, which we have no control over.

## Your Data Protection Rights (GDPR – for EU Users)

If you are a resident of the European Economic Area (EEA), you have the following rights under the General Data Protection Regulation (GDPR):

- The right to access – You have the right to request copies of your personal data.
- The right to rectification – You have the right to request correction of any information you believe is inaccurate or incomplete.
- The right to erasure – You have the right to request that we erase your personal data, under certain conditions.
- The right to restrict processing – You have the right to request that we restrict the processing of your personal data.
- The right to object to processing – You have the right to object to our processing of your personal data.
- The right to data portability – You have the right to request that we transfer the data we have collected to another organization, or directly to you.
